The Customer acknowledges that it has received the Master Agreement for the Hire of Plant and Equipment (attached to this Monthly Credit Account Term and Conditions) and has read and agreed to the terms and conditions contained therein (the Master Agreement for Hire of Plant and Equipment is also available online).

The Customer acknowledges and agrees that the Master Agreement for the Hire of Plant and Equipment and these Monthly Credit Account Terms and Conditions will apply to all contracts between itself and Rosnow Management Pty Ltd (ACN 106 906 978) and/or Rosnow Pty Ltd (ACN 010 282 532) unless otherwise agreed by the parties in writing prior to the supply of any Equipment by Rosnow Pty Ltd to the Customer.

The Customer acknowledges and agrees that submitting an order to the Company shall form a contract consisting of:

- 1. The details of the order, including any associated correspondence and communication that contains the terms of the hire;

The monthly credit account is provided on the following terms and conditions.

- 1. All goods and services supplied by the Company to the Customer during any calendar month must be paid for in full by the Customer on or before the Company's last trading day in the following month (the Due date).
- 2. A monthly billing cycle will apply. During each month the Company will render to the Customer a statement of account in respect of the preceding month.
